O PRESIDENTE DA CÂMARA MUNICIPAL DE TENENTE ANANIAS/RN, no uso das atribuições que lhe são conferidas pela Lei Orgânica do Município e, considerando o incommensurable interest public; considering, also, the formal conclusions motivated in the Legal Opinion, RATIFIES and HOMOLOGATES the ATO DE INEXIGIBILIDADE for the contracting of the company JAIANE CAMILO SOCIEDADE INDIVIDUAL DE ADVOCACIA – CNPJ (MF) nº 59.455.158/0001-07, specialized in the provision of technical services of consultancy and consulting in Protection of Personal Data, with the assignment of support entrusted by the treatment of Personal Data (DPO), aiming to attend to the requirements of the Federal Law nº 13.709/2018 – Lei Geral de Proteção de Dados Pessoais (LGPD), including technical orientation specialized, adequacy of administrative procedures internal, elaboration and implementation of privacy policies and protection of data, mapping of processes of treatment of personal data, support in data governance, issuance of technical opinions, training of servers, accompaniment of legal conformity and continuous assessment to the demands related to the protection of personal data in the scope of the Câmara Municipal de Tenente Ananias/RN.

The present contracting has technical-legal justification in Art. 74, inciso III, of the Federal Law nº 14.133/2021, in its current wording, whose contractual global value is of R\$ 54.000,00 (fifty and four thousand reais), to be paid in 12 (twelve) monthly equal and successive payments of R\$ 4.500,00 (four thousand and five hundred reais).
